Please review the following rules and regulations governing WEST TEXAS COMIC-CON, and if you have any questions or concerns, please contact us. By signing and returning the resulting contract, you confirm that you have read the following, agree to, and will comply with, all rules and regulations as stated below.

1. Space and Table rental: Each space is assigned on a first come first serve basis. Each space comes with (1) 6' or (1) 8' foot table, and (2) chairs. Electricity is free but not available in each booth. Please request in advance if your space requires electricity, because not all booths are currently equipped.
2. All booths must be manned at all times. WTXCC will not be held responsible for any issues arising from an unmanned booth during show hours.
3. Vendor/ exhibitor tables/ spaces must remain intact throughout the hours of the convention and may not be dismantled prior to the closing of the event. The show is not over until 6:00 pm on Saturday. It is unfair to other dealers and attendees to break down early. If you cannot stay until the end of the show, please do not set up.
4. Assignment of space will be by show management. We will try to accommodate as many special requests as possible but cannot guarantee space.
5. Exhibitors will comply with all local, state and federal laws, and will not hold management liable for any breaches, losses or damage to themselves or their property. All vendors/exhibitors agree to hold blameless WTXCC and all WTXCC staff members and workers against any loss, damage, theft, expenses, claims or actions arising from any personal or property damage, loss or theft due to said vendors/exhibitors participation in WEST TEXAS COMIC-CON.
6. In addition, all vendors/ exhibitors acknowledge that WTXCC and all WTXCC staff members, workers, volunteers and agents, will NOT provide or maintain insurance coverage for vendors/exhibitors persons or property, and it is their sole responsibility to obtain insurance covering loss.
7. WEST TEXAS COMIC-CON in no way endorses any vendors/exhibitors' merchandise, exhibits, views, beliefs, or actions. All vendors/exhibitors are deemed to be their own business/entity and in now way reflect the views, beliefs, intentions and/or direction of WTXCC. Vendors/exhibitors do not represent WTXCC in any way.
8. All merchandise bought or sold at the WEST TEXAS COMIC-CON is done strictly between vendors/ exhibitors and attendees/buyers, WEST TEXAS COMIC-CON is not party to or responsible in any way for any transactions made between said parties.
9. All adult materials must be either behind the table or, if displayed on a table or display rack bagged or covered so that minors may not open it. All vendors agree not to sell material of mature and/or adult nature to minors. Any adult material containing graphic sexual content will NOT be displayed or sold. Any vendor displaying or selling material containing graphic sexual content will be asked to leave the convention immediately.
10. **No Bootleg DVD;s or CD;s. Anyone selling unauthorized merchandise that infringes upon copyright or licensing agreements will be asked to leave the show.**
11. No live steel or weapons of any kind will be admitted to the WEST TEXAS COMIC-CON. This includes, but not limited to, swords, knives, shields and armor. **Absolutely NO firearms or ammunition of any kind!**
12. No booth will be reserved unless paid in full. There is a limited amount of space.
13. Should you (the dealer) find that you are not able to attend the WEST TEXAS COMIC-CON and have already paid for your booth(s), the policy is as follows: 100% refund if cancelled prior to October 20, 2009**NOTE** ANY CANCELLATION AFTER OCTOBER 20th 2009 WILL RESULT IN THE FORFEITURE OF ANY AND ALL PAYMENTS MADE TO THE WEST TEXAS COMIC-CON.
